-On December 7, 2012 the NPCC approved a new Rehabilitation Sciences course, RHSC 512, however 512 is a number already in use as a directed studies course. The pre-existing RHSC 512 is not published in the 2012/2013 Academic Calendar (although the course was scheduled in 2011W) and thus not visible to the public. As such, to avoid confusion, the program changed the number for the recently-approved version of the course from 512 to 514.

-Further to the January 11, 2013 NPCC meeting, Arts has resubmitted an amended course syllabus for POLI 552 (3) for review by the Committee Chair; the Chair is satisfied with the amendments; the new course proposal has been approved and will be put forward at the next meeting of the Senate Curriculum Committee.

-At the February 26, 2013 meeting of the Senate Curriculum Committee a new course from Applied Science, CIVL 556, was approved in principle, however the Committee asked if the description could be shortened. The request was forwarded to the proponent, who chose to shorten both the description and the title. The revised proposal has been accepted by Senate & Curriculum Services and will appear at the next meeting of the Vancouver Senate.

6. Chair's update on Strategic and Decision Support (SDS) Group

-Since November 2011, the approval process for new graduate programs has included mandatory review by the Strategic and Decision Support (SDS) Group for budgetary issues. This review is supposed to occur in the early stages of curriculum development, before proposals are submitted to the originating Faculty for review/approval. In recent months, however, the NPCC has become involved in the SDS portion of the curriculum approval process, either by raising questions that could possibly trigger further discussion with the SDS Group, or by having to follow-up with the group and/or proponent(s) to ensure the consultation has occurred and that the budget form has been signed by the necessary parties. The NPCC is a sub-committee of the Senate Curriculum Committee, which is a committee of the Senate, and as such the NPCC should not be discussing budgetary and financial concerns as they are not in the jurisdiction of the Senate (as per the University Act), although these concerns could have significant impact on proposed curriculum, which does fall within the NPCC's mandate. To ensure there is clarity on the part of the NPCC and the SDS Group with regards to the graduate curriculum approval process, Clive Roberts, Max Read, Jessica Iverson and members from Senate & Curriculum Services will meet with Janet Wang and Nelson Chan of the SDS Group to discuss procedures. Dr. Anna Kindler, Vice Provost and Associate Vice President Academic, will be brought into the conversation as necessary, as will the Senate Curriculum Committee.
