-Please note: Since the structure, format,	
and content is very similar amongst the	
suite of MEL/MHLP proposals, the	
following comments and	
recommendations can be applied to	
the other new program proposals.	
Some of the recommendations below	
have been made for other program	
proposals. Many of the changes noted	
below can be found in the	
accompanying document (an	
annotated version of the proposal	
containing the Committee's	
recommendations).	
-As recommended previously, please	
consider rewriting the proposal to	
remove repetition, 'sharpen' the	
document, clarify some of the	
terminology (platform, pillar, program),	
include program goals, and focus the	
market research section. This would	
significantly shorten the proposal.	
-It is recommended that the market	
research section focus on the area of	
engineering leadership relevant to	

MEL-AMM.

- -Some of the repetition has been identified in an annotated document and provided to the proponents postmeeting.
- -The rationale for optional "non-credit requirements" (i.e. co-op / entrepreneurial activities) need to be expressed clearly, including a clear outline of what is 'optional' and what is 'required' in this area. This is especially important for the student audience.
- -The course requirements for this program remain unclear.
- Please consider removing the specific list of courses from the "Proposed Calendar Entry" section on the 2-column Curriculum Proposal form.
- -The proposal needs to state unequivocally whether a co-operative education term is required or optional. Linked to this, an entrepreneurial activity seems to be an acceptable activity within 'co-operative education' already.
- -The proposal refers to "optional cooperative education term or entrepreneurial activity." Can students opt to do neither of these? As written, this is not clear. Also, is it feasible for students to complete a co-op term in a summer term where they have 7.5 credits of additional required course work? This is particularly relevant if the student is at a facility outside the lower mainland of BC for the co-op term.
- -Under the "Objectives" section, the first paragraph states "the overall objectives of the pillar are to..." Please ensure that it is clear that the 'pillar' referred to here is the new program. Try to maintain consistency in referring to the pillar as the technical component of the specific program (MEL- AMM Program).
- -At this point during the meeting, the Committee went in-camera for a short period of time.
- -Please consider removing the "Market Insights" section from the proposal document, or refocussing to this specific area of engineering.
- -Please ensure that when the proposal

- references "partner faculties", that the references identify the partner faculties by name.
- -Please remove or rephrase the last sentence in section 2.6 as the Faculty of Graduate and Postdoctoral Studies does not oversee these new programs.
- -Section 2.7.1 states that the CEEN program is changing from the MEng to the MEL. Please re-write this section to clarify this (creation of a new program).
- -In section 2.7.1, it is recommended that only the MEng programs be referenced as existing professional programs.
- -In section 2.7.2, please identify whether any similar programs within British Columbia or Canada provide a program with similar content (not just structure).
- -The "Enrolment Predictions and Capacity" section notes that there is demand for the MEng- CEEN program. It should also be noted here that the MEng CEEN program will be closing after the MEL- CEEN program is established.
- -Please ensure that the proposal and calendar entries are consistent in their reference to the constrained electives.
 Are these electives3 courses or worth 6 credits?
- -In the proposal, the Faculty of Commerce and Business Administration electives are listed in section 3.3.3, but there are no course numbers. Please either provide the course numbers/titles or remove this list. Please ensure titles are correct (see number 12).
- -It was noted that some of the proposed elective Business courses are worth 0.7 credits. If a student takes two 0.7 credit courses, this may cause the student to be 0.1 credits short of the requirements for graduation.
- -During the summer session, it appears that students are required to take 7.5 credits and also complete a co-op placement. This may not be possible.
- -The "Proposed Calendar Entry" section of the 2-column curriculum change form notes that the co-op placement is

- required, but section 3.3.5 notes that the co-op placement is optional.
- -Please consider re-importing all figures at higher resolution.
- -The Sustainability consult was only in relation to the APPP courses. Please ensure that this is noted on the Curriculum Consult Summary page.
