-It appears that LAIS 605 replaces the first half of LIBR/ARST 600, LAIS 607 replaces the first half of LIBR/ARST 610, and that LAIS 608 replaces the second half of LIBR/ARST 610. Please clarify what is happening to the content of the second half of LIBR/ARST 600.

-Response: The proponents will include a note that the previous system of study (second half of 600) was actually taken as a course outside of SLAIS. The new program requirements ensure that this PhD- LAIS: Change Prog. Requirements

The course must be pre-approved by the student's supervisor." Please clarify the level of course that must be completed. -Response: The parenthetical statement should simply say "(at the 500 level)." -In the proposed Calendar Entry, please ensure that the course titles for LAIS 608 and LAIS 609 are accurate. The title of LAIS 605 will also need to be changed to reflect the Committee's recommendation to change the title of the course.
- -In the proposed Calendar entry on the 2-column form, please remove "CR" when referencing a course's credit value in parentheses..
- -The proposed Calendar entry refers to LAIS 620 and LAIS 621. Neither are existing courses, nor does there appear to be any proposals to create these courses.
- -Response: The proponents will create the corresponding Category 2 proposals to change the ARST/LIBR 620-621 to "LAIS 620": and "LAIS 621"

will not be an issue. The proposals will be updated accordingly to remove reference to "first half" of LIBR/ARST 600.

- -Please clarify the requirements for the dissertation presentation as noted in the course schedule and assignments.

- -Please expand the rationale for the EdD in Reading Education being needed in addition to the PhD in LLED; presumably some students who would have done EdD in Reading Education have been successfully accommodated since the EdD was left dormant.
- -Please consider calling this a "new program" even though the terminology is referring to the "reactivation" of the program. It is advisable to note that the program is being "reactivated", but that it is essentially a "new program." This is because there is limited information about the old program, and the courses have presumably changed with the times, since EdD was active.
- -Please provide the credit values for the courses listed in the supporting document under the "Ed.D. in Reading Education" heading.
- -In the supporting document, please also be sure to note that the comprehensive exam allows for advancement to candidacy.
- -Please submit a formal curriculum consultation with the Faculty of Graduate and Postdoctoral Studies
