- The summary of priorities for review of syllabi was presented and the Committee agreed that this is appropriate.
- In light of the coming UBC policy on syllabi, the Committee discussed whether asking proponents to submit a sample syllabus is the best way to collect the prioritized information. The value of asking for a detailed rationale and the Committee's ability to assess academic merit across disciplines were explored. There was general agreement that this is a decision to be made by the Senate Curriculum Committee, not the GCC, but that this might be a good opportunity to highlight this Committee's expectations for the Faculty committees.

#### **APSC 542 (3)** – New course

- Leadership courses, including those within the MEL and MHLP, are normally taught by or in consultation with the Sauder School of Business, but they were not consulted during the development of this course
- The Committee would like to see a consultation with the Sauder School of Business before approving this course
- Friendly recommendations to consider before implementation of the course:
  - Clarify whether peer assessment is based on the assessments the student provides or the assessments provided by the student's peers
  - Make it clear whether the project report will be written collaboratively. If it is a jointly written report, will all group members receive the same grade?
