 - Non-LFS prerequisites are listed. Proponent should consult with those departments/faculties to give them some advanced notice.
 - The assessments in the Evaluation Criteria and Grading section do not add up to 100%. This should be resolved before offering the course.

- Assignment specific to graduate students in the cross-listed course is worth only 10% of the final grade. Consider making this a more substantial portion of the final grade.
- Consider adding information about grades for the group assignments will be assigned to individual students.
