**Graduate Certificate in Technology Based Distributed Learning** – Change program name, revise program overview

- Laddering language should specify a number of credits that can be transferred instead of number of courses.
- Proponents must provide a response to the consultation from the Department of Curriculum and Pedagogy.

#### Notes on the Women+ and Children's Health Sciences proposal packages as a whole:

- Discussion with proponents about their definition of "interdisciplinary" was helpful
  and could be better addressed in the proposal documents themselves. The
  proponents should say more in the written proposal about how this is an
  interdisciplinary program what they mean by interdisciplinary and how it plays out
  in the program.
- Indigenous must be capitalized. The phrase "Cultivate Indigeneity" must be removed from both proposals. Indigenous and First Nations do not mean the same thing and all instances of "First Nations" should be reviewed to ensure that is what is intended. Proponents must do a thorough scan of both documents for these issues.

#### PhD in Women+ and Children's Health Sciences – Create new program

- The proposal talks about the dissertation as if it is a course, but it is really quite
  different. While we must create a dissertation course code for registration purposes,
  when talking about it as a requirement for the degree in the proposal, the
  proponents should focus on the dissertation work itself (not the course number and
  credit value).
- Faculty members with Partner appointments must be removed from the membership list.
